The mission of CREWNY has been to promote and empower women in the Commercial Real Estate (CRE) industry. Working to achieve gender Equity & Inclusion in the workplace has been a key pillar of our mission from day one. - October 3rd, 2023: Winner(s) announced during the CREWNY October 3rd, 2023, Members Luncheon.

I. PROCESS, BENEFITS & CRITERIA

A. 2024 GRANTS AWARD PROCESS:

The Grants will be awarded to up to three (3) eligible Grant applicants. One (1) of the Grants are intended be awarded to professionals satisfying all the "Grant Requirements" set forth in <u>Section IIA</u> below for a Basic Membership Grant; and two (2) of the Grants are intended to be awarded to graduate students meeting the "Grant Requirements" set forth in <u>Section IIB</u> below for a Graduate Student Membership Grant (in each case, the "<u>Grant Requirements</u>").

In order for an applicant to be considered "eligible" for a Grant by CREWNY, the applicant must:

(a) meet all of the applicable Eligibility Standards

(b) complete and submit via the online link, all of the Application Documents, described in Section

<u>IIA or IIB</u> below, as appropriate, by the above deadline

(c) be available for an interview by the Grant Awards Team. Application Documents which are

incomplete in any way will not be reviewed or considered.

All Application Documents, including the Personal Financial Statement, are intended to remain strictly confidential, and shall be retained securely by and on behalf of CREWNY for administrative purposes only, being assessed by the Grants Awards Team. The Team shall not distribute, disseminate, or share the Application Documents, except to the extent necessary to conduct the Grants award process, or as required by applicable law. Any sensitive information you choose to supply in connection with applying for a Grant is completely **voluntary**.

The 2024 Grant Process, and awarding of the Grants, are subject in all respects to applicable laws.

C. GRANT AWARDS CRITERIA:

There are a limited number of CREWNY Grants available, which are needs-based and will be awarded based solely on merit. Applicants will be comparatively assessed by the Grants Award Team based on:

- Financial need considerations
- Your Interview
- Your Application Documents

II. GRANT REQUIREMENTS

A. BASIC MEMBERSHIP GRANT REQUIREMENTS [For CRE Professionals]:

- 1. <u>ELIGIBILITY STANDARDS</u>. In order to be considered eligible for a Basic Membership Grant, an applicant must currently:
 - Be, or identify as, female
 - Be employed in a substantially full-time professional position, or have an ownership interest in an entity, the primary responsibilities of which are in one or more of the Qualified Fields of Commercial Real Estate (QFCRE) listed in <u>Section C</u> below
 - Have at five (5) or more years of experience in a QFCRE
 - Work, have an office, conduct business, or have a controlling interest in a business located in the New York metropolitan or immediately surrounding area
 - Be of good character, having the highest professional and ethical standards and integrity
 - Actively support the achievement of parity in opportunity, influence, power, and compensation for all women in CRE.
- <u>APPLICATION REQUIREMENTS</u>. If an applicant meets all of the above Eligibility Standards, in order to be considered by CREWNY for a Basic Membership Grant, an applicant must submit via the online application, all of the following documents (collectively, for these applicants, the "<u>Application Documents</u>") to CREWNY by the above deadline:
 - Online Grant Application fully completed, signed, and dated
 - Personal Statement of Interest not exceeding 500 words, stating your reasons for wanting to join CREWNY and your career goals in CRE
 - Personal Financial Statement
 - Letter of Reference (from an employer, colleague or contact in commercial real estate)
 - Resume or CV or biography, briefly describing your professional career highlights (*e.g.*, education, employment, leadership positions and accomplishments)
 - Headshot [Optional]

B. GRADUATE STUDENT GRANT REQUIREMENTS [For Graduate Students]:

- 1. <u>ELIGIBILITY STANDARDS</u>: In order to be considered eligible for a Graduate Student Membership Grant, an applicant must currently:
 - Be, or identify as, female
 - Be enrolled substantially full-time in an accredited university or other educational institution in the New York metropolitan or immediately surrounding area, not scheduled to graduate before June 30, 2024
 - Actively pursuing a graduate degree in such university or educational institution in one of the QFCREs listed in <u>Section C</u> below
 - Be of good character, having the highest professional and ethical standards and integrity
 - Actively support the achievement of parity in opportunity, influence, power, and compensation for all women in CRE.
- 2. <u>APPLICATION REQUIREMENTS</u>. If an applicant meets all of the above Eligibility Standards, in order to be considered for a Graduate Student Membership Grant, an applicant must submit via the online application, all of the following documents (collectively, for these applicants, the "**Application Documents**") to CREWNY by the above deadline:
 - Online Grant Application, fully completed, signed and dated
 - Personal Statement of Interest not exceeding 500 words, stating your reasons for wanting to join CREWNY and your career goals in CRE
 - Personal Financial Statement
 - 2022/2023 Transcripts
 - Letter of Reference (from a professor, employer or contact in commercial real estate)
 - Headshot [Optional]
 - If you like, you may also include a resume or CV or biography briefly describing your professional career highlights (*e.g.*, education, positions, and accomplishments).
 [Optional]
