

# SPONSOR A SCHOLARSHIP

As a charitable add-on to any level annual sponsorship, sponsors can contribute a dollar amount, beginning at \$1,000 in support of CREW Greater Philadelphia's scholarships for young women pursuing a career in CRE, in partnership with CREW Network Foundation.

If the sponsor would like to have a scholarship in the donor company's name, the contribution must be \$5,000. At the \$5,000 level, benefits include company signage and recognition at the scholarship announcement event and a short donor speaking opportunity at the awards ceremony.

Donations to the scholarship fund less than \$5,000 will be added to the larger scholarship fund and the donor company will be named as supporting that fund.

Once you have committed to a sponsorship, you will receive a welcome letter with additional information and a point of contact for the Corporate Engagement Committee. You are encouraged to review the schedule of CREW Greater Philadelphia events monthly.

### **GENERAL INFORMATION**

Memberships are not transferrable. If an individual leaves a sponsoring firm, the membership stays with the person that had met the qualifications as defined in the Membership Brochure (link). If a sponsoring company would like to maintain membership, a new member would need to meet the qualifications and pay the applicable membership dues of \$395.00 for a full year membership or \$300.00 after June 15th.

Sponsoring companies can add additional CREW Greater Philadelphia members provided that the additional members have met the membership requirements as defined in the Membership Brochure.

Sponsorships and dues are non-refundable.

The monthly event benefit for members covered under the Annual Membership is to be used by one member per event per month. For sponsorship packages that include more than one member (Platinum and Gold), the monthly event benefit may be transferred from one CREW member of the sponsoring company to another. For example, if one member does not attend any events in a given month, they may transfer their event admission to the other sponsor company CREW member for that month.

### **AFFILIATE SPONSOR QUALIFICATIONS**

Affiliate members must meet the requirements for membership as defined in the Membership Brochure. The Affiliate company must agree to become an annual sponsor of CREW Greater Philadelphia.

Affiliate companies can sponsor at the Bronze level or higher.
