

CREW Network Impact Award: Rising Star

Purpose:

To recognize a CREW Network member who is a rising leader within CREW Network and the commercial real estate industry. This award will honor outstanding volunteer contributions, participation, and engagement in CREW Network activities (opposed to chapter activities). Honorees will be an inspiration to others to fully commit to advancing CREW Network's mission. This recognition celebrates the contributions of emerging talent to CREW Network.

Description:

The Rising Star Award recognizes an individual CREW Network member who has contributed at the CREW Network level through volunteering, engagement, and participation, and is known for their exemplary work in the industry. The individual is ambitious and energetic and has achievements in the industry as an emerging leader.

Criteria:

- Nominee must be a female, or an individual who identifies and expresses themselves in daily life as a female, with at least three, but no more than eight years of experience in commercial real estate.
- Nominee has demonstrated continuous and exceptional contribution to CREW Network, including but not limited to:
 - Member of a CREW Network committee(s)
 - Chair or co-chair of CREW Network committee(s)
 - Co-Lead of a CREW Network Council
 - Speaker, moderator, or panelist for CREW Network program(s)
 - Author of an Industry Brief, News You Can Use article or Member-to-Member deal story
 - Giving and getting business to/for other CREW Network members
 - Participation on CREWbiz Open Community
 - Participation in programs, Leadership Certificate, webinars, events
 - Completion of the Leadership Certificate Program

Note: Nominees are not required to complete all of the items listed above but the application should clearly demonstrate contributions at the CREW Network level (in addition to contributions at the chapter level).

- Nominee has led or been involved in industry projects that have been impactful to their company and/or the community.
- Nominee has distinguished themselves professionally, demonstrates great leadership qualities and actively works to guide and inspire others.
- Nominee must be a current, full member of CREW.
- Previous recipients of the Rising Star Award, CREW Network Board Members, CREW Network Foundation Directors, and members of the Recognition Committee are not eligible for the award.
