

CREW Network Impact Award: Sustainability Trailblazer

Description:

The Sustainability Trailblazer Award is CREW Network's newest Impact award and recognizes a member who has made a significant contribution towards their company's Sustainability goals. The recipient will display leadership in any (or all) of the Sustainability focus areas: environmental, social, or governance. The award committee will review both the company's Sustainability goals as well as the achievements of the individual in achieving those goals. The award recipient could be defined as a change maker who does not accept the status quo and instead strives to help their company make a positive change in the world.

Criteria:

- Nominee has responsibility for at least one of the Sustainability focus areas: environmental, social, or governance.
- The company of Nominee has a Sustainability statement and/or goals and has committed resources towards progress and achievement.
- Through his or her work, nominee will have made a positive impact to the commercial real estate industry. Nominee has demonstrated exceptional contribution to Sustainability which could include examples such as, but are not limited to, the following:
 - Defining, collecting, analyzing, and reporting on key performance indicators of Sustainability.
 - Changing supply chains, energy sources, or other facets of an enterprise-wide system to achieve goals.
 - Efforts to build a diverse and inclusive workforce and necessary amenities for all possible tenants.
 - Consideration and investment in the broader community through revitalization, infrastructure support and/or tenant health/wellness.
 - Establishment of transparency on management practices, policies, and internal controls.

Note: The items listed above are only examples, however nominees should be able to demonstrate areas where they have substantially contributed to Sustainability.

- Nominee must be a current, full member of CREW.
- CREW Network Board Members, CREW Network Foundation Directors, and members of the Recognition Committee are not eligible for the award.
