[ ] Affiliate Member (Vendor) A member who does not meet the requirements of Article V, Section 1, Section 2.A, or Section 2.B of the by-laws and are classified as "vendors". Affiliate members shall be defined as persons who actively market their services to the commercial real estate industry but are not directly part of a real estate transaction as described in Article V, Section 1 of the by-laws.

[ ] Retired Member A member who has retired on a full-time basis (not a partially retired basis) as described in Article V, Section 2, Section 2.E of the by-laws.
